 Product Roadmap contributed to client retention of 98.7%, in addition to generating a robust sales pipeline in excess of \$5M. Launched first version of a new employee recognition product in record 6 months and a new ERP (Acumatica) in 17 months by conducting due diligence, RFP and establishing a core team.

- Co-led a Value Stream Mapping exercise and implemented a Lean Approach to technology tactics. Identified 24 areas for process improvement, with 92% of them being closed in 7 months.
- Established Agile@Inspirus to promote Agile as the guiding principle for all product development. Introduced DevOps and Automation. Created Product-based persistent agile teams. All of these led to an increased throughput of deliverables by ~ 50% year-over-year.
- Invested \$1M in new technology and solutions to revamp Infrastructure and Security. This has eliminated all end-of-life, and end-of-service-life software and systems and brought them to current and supportable versions. Over 65 security vulnerabilities were fixed, leading to a successful external security audit with no findings 3 years in a row.
